(Italian Forensic Geneticists) board has set up a working group aimed to develop the "Code of conduct of a Forensic Geneticist". This group includes all practitioners working in the field of forensic genetics. The rules of the code of conduct apply to forensic geneticists belonging to the GeFI group and all of those sharing the GeFI's mission, vision and values applicable to their professional practice, reciprocal relationship and relationship with third parties.

# 1. Introduction

A forensic geneticist uses modern molecular biology techniques for personal identification and parental relationships. He/she works as an expert witness for the Judicial Authority in both civil and criminal proceedings, and also for private individuals at request.

In Italy, forensic geneticists have however no official recognition that should provide certain rights and responsibilities to them: practitioners from various fields such as legal medicine, biology, biotechnology, with adequate qualifications, dedicate themselves to this discipline. The only possible restraint upon professional misconduct of a forensic geneticist is through membership of a scientific society or association, which establishes membership rules. Therefore, there is need to establish codes of conduct, which should be reviewed regularly to meet the growing scientific-technological advancements, novel laws and regulations, and any changes of deontological codes.

## 2. Material and methods

The code of conduct of forensic geneticists developed by the GeFI group consists of 7 chapters and 23 articles, which describe general principles, relationship with other forensic geneticists, duties of forensic geneticists testifying in Courts of Law, importance of informed consent privacy protection, and etc (Table 1).

## 3. Results and discussion

The code of conduct of the forensic geneticist developed by the GeFI group includes general principles concerning the professional activity of the forensic geneticist and in particular, the relationship with other forensic geneticists, duties of forensic geneticists testifying in court, importance of informed consent, respect for privacy, etc. The principles of the deontological codes applicable to all professionals within the forensic genetics profession as well as all main roles and responsibilities of forensic geneticists were considered [1-5]. The code emphasizes the importance of professional development in order to guarantee high

quality standard and proficiency in forensic DNA practice.

Another important aspect stated in the code of conduct relates to the management of relationship with media; a forensic practitioner must be inspired by criteria of balance and transparency and comply with duties of discretion and confidentiality.

The rules of conduct apply to all forensic geneticists belonging to the GeFI group and to all those who share the GeFI's mission, vision and values applicable to their professional activity, reciprocal relationship and relationship with third parties. This code of conduct is intended to be an ethical guide not imposed by outside legislations and hence members voluntarily adhere. The guiding principles considered were drawn from professional deontological codes of each profession

involved in the forensic genetics field as well from suggestions made by the forensic scientific community. The principles were written with the hope that all forensic geneticists will incorporate them into their daily forensic practice and will also describe some specific rules to supplement existing codes adopted by professional organizations. Indeed, these principles are intended to create a culture of ethical behavior and professional responsibility.

The code of conduct is designed to promote full integrity among forensic DNA practitioners and increase public community confidence in the quality of forensic genetics. It is not meant to be that these principles are all-inclusive, but they represent general standards that each forensic geneticist should know and follow. Serious or repeated violations of these principles may be regarded as inconsistent and incompatible with the GeFI membership status. It is up to the Disciplinary Commissions of the professional registers to determine the adequate sanctions proportional to the ethical violation committed and in compliance with procedures and policies defined in the rules. All violations must also be reported to the interested Professional Boards.
